Discussion questions

In reading the materials, seminar participants are invited to reflect on two issues in particular for preparing the discussion:

How can we define urban infrastructure? What do changing meanings and material forms of urban infrastructure imply for architects and urban designers?

What are potential effects of commodity flows on contemporary urban space – and how are infrastructure systems and objects mediating them?
